

Certification and Accreditation

An overview

Accreditation is a vital part of our work at EBU, ensuring that our students, candidates, and graduates have met specific standards for learning, experience, and professional outcomes.

For your understanding, Accreditation is a quality assurance process that colleges, universities, and education institutions or programs undergo to confirm that they meet a strict and recognized set of service and operational standards.

Accreditation is assessed by private, nongovernmental accrediting agencies created specifically to review education institutions and programs. These external college accreditation agencies are reviewed and recognized by different entities relative to the country's geographic location.

EU Global is accredited by the Malta Further and Higher Education Authority (MFHEA), granting it the authority to offer Bachelor's, Master's, and Doctoral programs. These programs are aligned with the European Qualifications Framework (EQF) and the Bologna Process, ensuring recognition across the European Union.

It is important to distinguish between university accreditation and program accreditation. Institutions or universities maybe institutionally accredited, with only a specific specialised (engineering or computing) degrees within the university accredited at the program level. Further, as accreditation of a program can take several years to complete, a program may be in the process of being accredited, or have achieved provisional accreditation, but not yet be fully accredited.

The two types of accreditation are institutional and programmatic.

As the name suggests, institutional accreditation applies to an entire institution. The accreditation agency looks at the school as a whole, from governance and finances to program design, learning outcomes, and student support services. Institutional accreditation gives a stamp of approval to Institutions. By attending an accredited school, you can easily transfer credits to other institutions. Graduate programs and employers will also recognize your degree as valid.

Perhaps most importantly, institutional accreditation allows colleges to participate in funding — the student aid money most institutions and students rely on.

What Is Programmatic Accreditation?

Unlike institutional accreditation, which targets entire schools, programmatic accreditation — also called specialized accreditation — targets individual programs in institutions and universities.

Agencies offering programmatic accreditation either focus on one program, like nursing, or a set of related programs, like those in STEM fields. Whereas the quality standards upheld by institutional accreditation focus more on the big picture, those set by programmatic accreditation tend to be more specific.

Attending an accredited program is extremely important in certain fields — particularly professional pathways like healthcare, law, and education — and determines whether you can attend graduate school and take national licensing exams.

European Global Institute of Innovation & Technology (EU Global) is a Malta Further & Higher Education Authority (MFHEA) Licensed (accredited) Higher Education Institute, which offers ECTS accredited qualifications and aims to promote European Educational Excellence globally.
